## **Question by** John Biggs

Are you acquainted with the idea that at a relatively low cost this might be extended, mainly over existing lines but also across development land to help facilitate regeneration of the Barking Riverside area? Is this an initiative you are happy to explore?

## Answer by Boris Johnson

TfL is currently reviewing options to help facilitate growth in the Barking Riverside area. One option under consideration is the possible extension of the Overground network from Barking station to terminate at Barking Riverside. Engineering and demand assessments are underway to assess the feasibility and cost of this.

The answer to question No. I seems to indicate that the Mayor has made his first personal approach to a Minister or Secretary of State for Transport regarding the Barking – Gospel Oak Line electrification issue since his 'spat' with Labour Transport Secretary Lord Adonis back in 2009. It also confirms BGOLUG's understanding that Transport for London were in active negotiations with Network Rail (NR) and the Department of Transport (DfT). BGOLUG thanks John Biggs for his help in shining some light on this somewhat murky affair.

The bumper Golden Anniversary October edition of *Modern Railways* should be in the shops tomorrow and carries a letter from BGOLUG's previous secretary, Graham Larkbey highlighting the folly of not including Barking – Gospel Oak electrification in the Government's July HLOS announcement (thanks Graham) along with the news that TfL is in negotiations with NR to get the scheme included in the 2013 NR Strategic Business Plan. Industry and Technology Editor Roger Ford's Informed Sources Preview email is included in this dispatch.

Also attached is a copy of the article on the line that appeared recently in *RAIL* 703 which has been kindly supplied to BGOLUG by the publisher.

#### LONDON GATEWAY DEVELOPMENTS

Not reported so far was the news in August's *Modern Railways* that major rail freight haulier DB Schenker (DBS) had signed a deal with DP World, the developers of the new super deep-sea port at Thames Haven (Corringham) on 2<sup>nd</sup> July to provide rail services from the opening of the terminal next Autumn. DBS will operate at least four arrivals and departures serving the three shipping berths that will be operational at opening. When fully operational there will be six shipping berths and the two square mile site will contain Europe's largest logistics park. It is hoped to be able to write more about London gateway in the near future.
