Latest News 6th October 2018

Network Rail has at last been able to give Type Approval to Bombardier Rail UK for the new London Overground Class 710 trains. Night-time test runs have been made over the Barking – Gospel Oak route and mileage accumulation runs, also overnight, on the West Coast Main Line to Crewe have started. Before handover to London Overground operator Arriva Rail London, each train must achieve 2,000 miles fault free running. Then route clearance and driver training can start, each driver receiving a 4-day conversion course.

BGORUG believes that providing there are no other problems with these trains, a big enough pool of drivers *could* be trained in time to allow the first train to enter public service by the end of November, some ten months later than originally planned. The full Barking – Gospel Oak service should be operated by the 4-car electric trains by the turn of the year.

In the meantime, it is believed that the phased transfer to West Midlands Trains of the seven remaining subleased 2-car diesel trains that currently maintain the Barking – Gospel Oak service will continue. They will join 172 002 which moved to the operator's Birmingham Tyseley depot at the end of June. The shortage of diesel trains means that there is no regular cover for any trains that break down in service. The transfer of any further trains will only exacerbate the situation, making it almost impossible to operate the existing timetable. Passengers are advised to allow plenty of time for their journeys as there may be cancellations, extended intervals in service and serious overcrowding,

CLOSURE OF LONDON OVERGROUND BOOKING OFFICES
